The *Investment Industry Hall of Fame* was created in 2013 to honour excellence, integrity and leadership in Canada's investment industry. To date, 45 distinguished industry professionals have been welcomed into the Hall of Fame.

"The inductees of the *Investment Industry Hall of Fame* this year are individuals who have displayed vision and leadership in the industry and capital markets, and have given support to individuals and to charitable organizations and institutions in their communities. Their careers have contributed to more vibrant capital markets, to a more prosperous country, and to better lives of everyday Canadians. The Inductees were chosen by members of the *Investment Industry Hall of Fame* Selection Committee, an independent group of distinguished Canadians who work, or have worked, in politics, the law, academia, business or the investment industry.

The annual *Investment Industry Hall of Fame* Gala Dinner and Induction Ceremony will be postponed this year, in light of the COVID-19 crisis. This decision has been made for the safety of all involved. The 2020 Inductees will be formally recognized and celebrated in October 2021 in Toronto.
